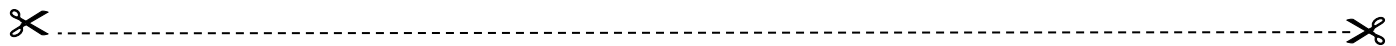

### Season Ticket

Payment of £35 (or £60 for two people at one address) secures a season ticket for a year and advance notice of concerts and other events

### Friend-Supporter level
